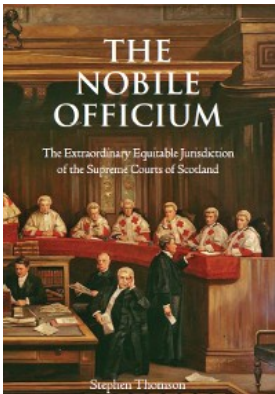

The *nobile officium* is an equitable, rather than a strictly legal, jurisdiction. It provides the courts with a discretion to grant a remedy on the basis of justice, fairness and equity, in the spirit of the law rather than its letter. It may be applied to any issue which is justiciable in the supreme courts of Scotland, including such diverse areas as trusts, bankruptcy and statutory omissions.

This is the first dedicated study of this extraordinary and unique jurisdiction. The text brings together the many applications of the *nobile officium* and provides commentary, analysis and rationalisation. It offers general guidance on how and when the *nobile officium* might be applied, and raises general awareness of the potential of this jurisdiction.

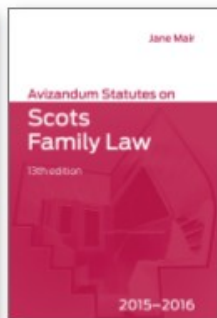
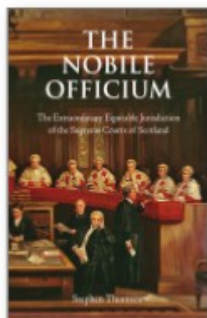
